NOTIFICATION

The Director, IARI & the Chairman, Academic Council, IARI is pleased to approve the guidelines recommended by the Standing Committee on Faculty and Discipline on engagement/recognition of IARI faculty as Adjunct Professor/Adjunct Faculty by another Indian/Overseas Universities. The guidelines are as follows:

- IARI faculty will seek the permission of Dean and Director, IARI through his/her respective Board
 of Studies to become Adjunct Professor/Adjunct Faculty in other universities/ institution:
 - (i) Before submitting the application to such universities/institutions
 - (ii) After nomination, if nominated by such universities/institutions
- There will be no financial liability on the part of ICAR/ICAR Institutes.
- He/She will be allowed for part time teaching only, and cannot conduct research or participate in administrative duties in host institutions.
- He/She will have to make maximum four visits in a year to the host institution, and may be allowed to leave parental institute for a maximum of 5 working days per visit.
- Since financial activities are involved, the concerned faculty will not be treated on duty/tour from
 the parental institute for his/her absence in parental institute to perform the duties of Adjunct
 Professor/Adjunct Faculty in host institute/university. He/She will have to avail Earned Leave for
 this purpose.
- He/She will work as Adjunct Professor/Adjunct Faculty at only one host institute/university at a time.
- The faculty will submit an undertaking with application that the work load/commitment at parental institute will not be diluted during his/her tenure as Adjunct Professor/Adjunct Faculty.
- There should be no conflict of interest between parental institute and host institute/University.
- The permission to join Adjunct Professor/Adjunct Faculty shall not be treated as matter of right. It will be considered on merit, and keeping in view the prevailing circumstances of parental institute at the time of application.
