Subject: Urgent Request for Release of Waiting List for ICAR-IARI Assistant Recruitment and Concern Over Relocation Requests

Respected Sir/Madam,

I hope this message finds you well.

I am writing to raise a serious concern regarding the delay in releasing the waiting list for the ICAR-IARI Assistant recruitment. It has been over a year since the publication of the merit list, yet the waiting list, as outlined in the notification dated 25.06.2024 (F. No. 2-1/2022/Rectt. Cell/Administrative (CBT)), has not been released. As per the Office Memorandum (OM) dated 16.04.2025, any vacancies arising from non-joining or resignation must be filled from the waiting list. However, no action has been taken so far.

While the relocation of candidates to ICAR Headquarters and Institutes is part of the prescribed process, it has come to my attention that some relocated candidates are dissatisfied with their allocated locations. These candidates are attempting to pressure ICAR to change their postings to preferred sites, which is against the established rules. ICAR's role is not to cater to personal preferences but to follow a fair, merit-based allocation system. Allowing such demands would compromise the transparency and fairness of the entire recruitment process, and could lead to unjust allocations that undermine the integrity of the system.

The undue influence being exerted by some of these relocated candidates to change their placements creates an unfair situation for all other candidates waiting in the reserve panel. It is vital that the recruitment process be carried out strictly as per the rules, without yielding to pressures that could distort its fairness.

In light of these concerns, I respectfully urge your office to expedite the release of the waiting list and ensure that the recruitment process remains transparent, fair, and free from any undue influence.
