I am writing to lodge a grievance regarding the unexplained delay in publishing the waiting list for DR-Assistant posts arising from the Combined Assistant Grade Examination-2022 (CAGE-2022), conducted by ICAR-IARI.

The ICAR Office Memorandum (F.No. Admn.16-5/2024-R.&P) dated 16.04.2025 had laid down a clear plan:

- The one-time re-allocation exercise at ICAR Institutes/KVKs was to be completed by 31st May 2025.
- Subsequently, the operation of the waiting list for filling remaining vacancies (due to non-joining, resignation, or movement) was to begin from 5th June 2025.
- The OM explicitly mentioned that the process should not be delayed by waiting for physical joining of re-allocated candidates, once their unconditional consent was obtained.

However, even after the re-allocation list was published a month ago, the waiting list has not been published till date, contrary to the approved execution plan. This has created deep anxiety among waitlisted candidates, who have already been waiting for more than two years for their rightful opportunity.

Through this grievance, I most respectfully request clarification on the following:

1. The revised timeline by which ICAR will now publish and operate the waiting list.
2. Reasons for the delay in publishing and operating the waiting list despite the re-allocation list already being published.
3. The steps being taken to ensure that further delay does not unfairly disadvantage waitlisted candidates.



I humbly request the PMO's intervention to ensure that ICAR strictly adheres to its own Office Memorandum and carries out the process in a time-bound and transparent manner.


