

In continuation of my petition dated 18.07.2024, 30.08.2024, 23.10.2024, 20.12.2024, 20.01.2025, 06.02.2025, 04.04.2025, 28.04.2025, 22.05.2025, 24.07.2025, 29.08.2025, 09.10.2025, 05.11.2025, 23.12.2025 and 22.01.2026 with reference to the directives of the Government of India, Ministry of Education,, Department of Higher Education, New Delhi vide letter No.F.No.13-4/2024-U.3(A) dated 30.05.2024 (vide Enclosure) regarding the release of my salaries and other dues w.r.t. my petition dated 29.04.2024 (vide Enclosure), I regret to state that nothing has been heard so far in the matter even after a lapse of one year and six months since the release of the said directives of the Government of India.

In this connection I submit to reiterate that by virtue of the legal status of the IARI as deemed to be University as of 1958 under section 3 of the UGC Act, 1956 vide UGC Notification 2006-07 (vide Enclosure), my central service as of 1972 in IARI as Gazetted Teaching Faculty of Agriculture has been restored and recognized by the UGC vide letters No.F.5-3/2015 (CPP-I/DU) dated 01.04.2015 and 17.12.2021 (Two) vide Enclosure as well as Govt. of India, Ministry of Education, Department of Higher Education vide office Memorandum vide F.No.13-3/2021-U.3A dated 02.05.2022 (vide Enclosure).

Besides I would like to bring it to your kind notice that my faculty status as Gazetted Teaching Faculty at IARI has been recognized by Government of India Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), Establishment (Pay-I) Section vide Office Memorendum vide F.NO:19.22026- Pers. Policy (Promotion) dated 05.01.2026 (Vide Enclosure) as well as by Ministry of Agriculture & Farmers Welfare (General Coordination Section) vide Office Memorandum vide F.NO:11030/16/2025-GC dated 13.01.2026 (vide Enclosure)

Matter pertains to release of salaries and other dues to an retired employees which does not come under the purview of P.P. Pay Division.

Therefore, I am entitled for the Career Advancement since 1972 w.r.t. my faculty status as Gazetted Teaching Faculty of Agriculture as per the rules framed by the UGC from time to time as well as the age of superannuation and consequential statutory benefits as per the HRD Notification dated 27.07.1998 vide letter No. F.I-22/97- U.I. issued on 27th July, 1998 by Government of India, Ministry of Human Resource Development (Department of Education), New Delhi.

In view of the inordinate delay in the matter under the subject I would further bring it to your kind notice that I have not yet availed the consequential benefits of the 3rd, 4th, 5th, 6th and 7th Central Pay Commission recommendations to till now, w.r.t. the Career Advancement for the Gazetted Teaching Faculty as per the rules framed by the UGC from time to time.

As you are aware, I have been pursuing the matter under the subject for the past 27 years since 1998. Due to inordinate delay in the release of my salaries and other dues up to date with effect from 01.01.1999, I am facing acute financial hardship at the old age (Super Senior) without monthly income.



In continuation of my petition dated 18.07.2024, 30.08.2024, 23.10.2024, 20.12.2024, 20.01.2025, 06.02.2025, 04.04.2025, 28.04.2025, 22.05.2025, 24.07.2025, 29.08.2025, 09.10.2025 and 05.11.2025 with reference to the directives of the Government of India, Ministry of Education., Department of Higher Education, New Delhi vide letter No.F.No.13-4/2024-U.3(A) dated 30.05.2024 (vide Enclosure) regarding the release of my salaries and other dues w.r.t. my petition dated 29.04.2024 (vide Enclosure), I regret to state that nothing has been heard so far in the matter even after a lapse of one year and six months since the release of the said directives of the Government of India.

In this connection I submit to reiterate that by virtue of the legal status of the IARI as deemed to be University as of 1958 under section 3 of the UGC Act, 1956 vide UGC Notification 2006-07 (vide Enclosure), my central service as of 1972 in IARI as Gazetted Teaching Faculty of Agriculture has been restored and recognized by the UGC vide letters No.F.5-3/2015 (CPP-I/DU) dated 01.04.2015 and 17.12.2021 (Two) vide Enclosure as well as Govt. of India, Ministry of Education, Department of Higher Education vide office Memorandum vide F.No.13-3/2021-U.3A dated 02.05.2022 (vide Enclosure), and thereby I am entitled for the Career Advancement since 1972 w.r.t. my faculty status as Gazetted Teaching Faculty of Agriculture as per the rules framed by the UGC from time to time as well as the age of superannuation and consequential statutory benefits as per the HRD Notification dated 27.07.1998.

In view of the inordinate delay in the matter under the subject I would further bring it to your kind notice that I have not yet availed the consequential benefits of the 3rd, 4th, 5th, 6th and 7th Central Pay Commission recommendations to till now, w.r.t. the Career Advancement for the Gazetted Teaching Faculty as per the rules framed by the UGC from time to time.







In this connection, it is to informed that this office has already send reply vide letter of even no. dated 07-05-2015, 28-05-2015, 19-06-2015, 30-06-2015, 17-08-2015, 31-12-2015, 02-06-2015, 19-08-2016, 24-10-2016, 23-12-2016, 27-07-2018, 06-03-2024, 24-04-2024, 14-06-2024, 09-08-2024,13-11-2025, 16-12-2025, 29-01-2026, 18-02-2026 and 09-03-2026 to you in this regard.

Further, it is again inform that following reply was sent to you as under :

1. This office vide letter dated 27-07-2018 that the final reply on the issue of the Date of Birth and age has already been issued by the Council and the same was connedy to you vide this office letter of even No. dated 07-05-2015.
2. Your were superannuated from the Council's service on 31-12-1998 on attaining the age of superannuation (i.e. 60 years) as per the extent rule applicable at that time. The suit for enhancing the date of superannuation age from 60 years to 62 years has already been dismissed by the Hon'ble court. Hence, no pay and allowances can be paid for the period of two years.
3. The Pension and other benefits as admissible have already been accorded as informed by the Sr. Finance and Account officer vide his letter No. 1-11/Pension Audit/13-14/1785/4 dated 18-06-2018. December 2018 due to the non – availability of his bank account details and several reminders issued but, the required bank details have not yet been received from Dr. R.Rangaraju (copy enclosed).
