I am writing to express my concern over the significant delay in releasing the WAITING LIST for the post of Assistants in ICAR and request respectfully to expedite the process for the same. The vacancy for the post of Assistants was published vide Advertisement No. 2-1/2022/Rectt. Cell/Administrative (CBT) and all the due processes of examinations were done long back. It has also been over a year since the final merit list was declared, and despite multiple notifications issued by ICAR regarding reallocation of vacant positions due to non-joining and resignations of the candidates the waiting list remains unpublished yet, causing profound anxiety and uncertainty among candidates.

As per the official notices:

1. Notice dated 25.06.2024 outlined the operationalization of the waiting list to fill the vacancies arising from non-joining or resignation.
2. Notice dated 08.07.2025 and 30.07.2025 provided updates on the ongoing reallocation of Assistant posts and the process for filling vacancies.
3. Notice dated 18.07.2025 mentioned the continued efforts for reallocation, yet the waiting list remains pending.

While we acknowledge the complexities of recruitment, timely action and communication are crucial for fairness. We therefore, request that a clear timeline be provided for the release of the waiting list. The delay in finalizing the process has caused insignificant restiveness among many eligible candidates who have been waiting for over a year for an opportunity to join and serve ICAR IARI.

We hereby respectfully urge the concerned authorities to provide a definitive timeline for the release of the WAITING LIST and expedite the process at your earliest convenience.

Thank you for your attention to this matter. We are aggrieved by the delay and looking forward in anticipation to your prompt response and a clear timeline for the release of the Waiting List. Provide a clear timeline and transparency regarding the delay.
