Respected Sir/Madam,

I am writing to respectfully request the expedited release of the waiting list for the Assistant position at ICAR IARI. It has been over a year since the release of the final merit list, and despite the multiple notifications issued by ICAR regarding the reallocation of vacant positions due to non-joining or resignation of candidates, the waiting list has not yet been published.

As per the official notices:

- 1.) Notice dated 25.06.2024 outlined the operationalization of the waiting list to fill vacancies arising from non-joining or resignation.
- 2.) Notice dated 08.07.2025 and 30.07.2025 provided updates on the ongoing reallocation of Assistant posts and the process for filling vacancies.
- 3.) Notice dated 18.07.2025 mentioned the continued efforts for reallocation, yet the waiting list remains pending.

Given the above, we request that a clear timeline be provided for the release of the waiting list. The delay in finalizing this process has caused significant uncertainty for many hopeful eligible candidates who have been waiting for over a year for an opportunity to join ICAR IARI.

We respectfully urge the concerned authorities to provide a definitive timeline for the release of the waiting list and expedite the process at the earliest.

Thank you for your attention to this matter. We look forward to your prompt response and a clear timeline for the release of the waiting list.


