Subject: Urgent Request for Expediting Recruitment Process from Reserve Panel

Kind attention is invited to the Office Memorandum (OM) dated 16.04.2025, issued under F.No. Admn.16-5/2024-R&P. As per Clause ii(c), it was directed that, during the reallocation process to ICAR Hqrs/Institutes/KVKs, an undertaking regarding the willingness of reallocated candidates should be obtained to join the newly allocated locations. This measure was introduced to avoid delays and to enable the subsequent steps to proceed without waiting for the actual joining of the candidates at the new locations.

However, it has come to notice that despite the reallocation process to ICAR Hqrs/other Institutes/KVKs having been finalized, there is a significant delay in issuing the waiting list for candidates in the reserve panel. It is also important to note that it has now been 12 months since the merit list for the ICAR-Assistant 2022 examination was published.

This delay in publishing the waiting list, despite the OM dated 16.04.2025 being issued more than 4 months ago, has caused considerable distress among the candidates in the reserve panel.

In light of the above, it is respectfully requested that necessary steps be taken to expedite the recruitment process for candidates from the reserve panel, while ensuring strict adherence to the instructions outlined in the OM dated 16.04.2025.

Your prompt attention to this matter will be highly appreciated.
