This has reference to your RTI letter with Registration No. ICARH/R/E/25/00371 dated 04.08.2025 received in the HRD Section of the Agricultural Education Division dated on 05.08.2025, seeking some information as per provisions of the Right to Information Act, 2005. The request has been examined and the following information is provided.

<p>I am writing this application with utmost sincerity and a heavy heart regarding the recent developments about the closure of the B.Tech (Agricultural Engineering) programme at IARI New Delhi for the upcoming academic session 2025-26. Let me humbly explain my situation: I am not currently enrolled at IARI Delhi. However, I appeared for the ICAR-UG entrance exam with the sole intention of securing admission into the B.Tech (Agricultural Engineering) course at your esteemed institution. In the previous academic session 2024-25 I was offered admission to several reputed colleges including GBPUAT Pantnagar. However, I chose to withdraw my seat solely to reattempt the exam and aim for IARI Delhi considering its unparalleled reputation in the field of agricultural sciences akin to IIT Delhi or AIIMS Delhi in their respective domains. Had there been an official notification or indication about the closure of the B.Tech course at IARI Delhi at least one academic session in advance I would not have taken the difficult decision to forego my seat last year. The sudden closure has led to an unintended wastage of one precious academic year of my life. My preparation for the entrance exam throughout the past year was solely focused on securing admission at IARI Delhi. It seems unfair and discouraging that after putting in a year of effort with a clear vision the goalpost itself has been removed. My humble request is not for a permanent reversal of the decision but only to allow the UG admissions for one final session i.e. 2025-26. This would be a fair and compassionate gesture towards students like me who made life-changing decisions based on the prestige and academic excellence of IARI Delhi. I understand spatial and administrative constraints but it is observed that the B.Sc. (Hons.) Agriculture programme is being relocated to IARI Jharkhand and Assam campuses. Since B.Tech seats are significantly fewer in number compared to B.Sc. if space is a concern, it may still be feasible to continue the engineering course at IARI Delhi. It is not fair to permanently close engg degree while seats are already less. I place my complete faith in the wisdom and empathy of the authorities. Kindly consider this as a heartfelt plea from a student whose academic future has been deeply affected. A positive decision in this regard will not only restore my faith in the system but also preserve the dignity and vision that IARI Delhi stands for.</p>	<p>This decision of discontinuing the Undergraduate programs at ICAR-IARI, New Delhi and its hubs, except at IARI Assam and IARI Jharkhand has been taken by the competent authority of the ICAR.</p>
