Subject: Request for Expedited Release of Waiting List for ICAR-IARI Assistant Recruitment

Respected Sir/Madam,

I hope this message finds you well.

I am writing to formally express my concern regarding the significant delay in the release of the waiting list for the ICAR-IARI Assistant recruitment, which is now long overdue. As per the notification dated 25.06.2024 (F. No. 2-1/2022/Rectt. Cell/Administrative (CBT)), any vacancies arising due to non-joining or resignation are to be filled from the waiting list. However, despite the considerable vacancies being reported, as shown in the various communications including the notices dated 08.07.2025 and 30.07.2025, the waiting list has yet to be released.

It has now been over a year since the publication of the merit list, and the candidates from the reserve panel have been left in a state of uncertainty. As per the Office Memorandum (OM) dated 16.04.2025, it was clearly outlined that the vacancies due to non-joining would be filled expeditiously. However, the delay in the release of the waiting list is not only causing undue stress to deserving candidates but is also undermining the transparency of the recruitment process.

Additionally, there have been reports indicating that some candidates, already posted in Institutes, are seeking unauthorized re-allocations or preferential postings, despite the clear instructions that allocations are final once made. Such actions, if entertained, could severely compromise the fairness of the process.

As stipulated in the notices (including those dated 25.06.2024 and 08.07.2025), vacancies arising at ICAR Institutes and Headquarters should be filled strictly from the waiting list. The delay in this process, and the potential alteration of allocations based on undue influence, is against the integrity of the recruitment process and the policy established by ICAR.

I respectfully urge your office to intervene and ensure the expedited release of the waiting list, so that the rightful candidates can be considered for appointment in the vacancies created due to non-joining or resignation. This will help ensure that the recruitment process remains fair, transparent, and free from any

undue influence.
