Respected Sir/Madam,

I hope this message finds you well. I am writing to formally escalate a matter that has caused significant distress and uncertainty. I have previously raised a grievance (PMOPG/E/2025/0144436) regarding the prolonged delay in the release of the waiting list for the Assistant position at ICAR IARI. However, the responses received have not addressed the core issues, and my subsequent appeal was closed without a satisfactory resolution.

The details of my complaint are as follows:

Date of Complaint: 22/09/2025

Reference: PMOPG/E/2025/0144436

Status of Appeal: Closed without resolution

Appeal Reference: DOARE/E/A/25/0000078

Despite receiving multiple notices from ICAR regarding the reallocation of Assistant posts due to non-joining or resignation, no concrete timeline has been provided for the publication of the waiting list, nor have any steps been outlined to expedite the process.

The responses I have received thus far have been general, repetitive, and failed to address my specific request for a definitive timeline for the release of the waiting list. This has led to further frustration and uncertainty for eligible candidates like myself who have been waiting for over a year.

In light of the above, I respectfully request that the Ministry intervene and address the following:

- 1. Provision of a clear, actionable timeline for the release of the waiting list for the Assistant position at ICAR IARI.
- 2. Clarification on the steps ICAR IARI is taking to expedite the finalization of vacancies and the publication of the waiting list.
- 3. Immediate intervention to ensure that all candidates are treated fairly and transparently in this process.

The lack of clarity and delay in providing an adequate response undermines the integrity of the recruitment process and the faith of candidates in the fairness of the system. I kindly urge the Ministry to intervene and ensure the issue is addressed promptly and transparently.
