Subject: Request for Intervention in Delay of Waiting List Release – ICAR-IARI Assistant Recruitment & Redressal of Unresolved Grievances

Respected Rashtrapati Ji,

With due respect, I write to seek your kind intervention regarding the delay in releasing the waiting list for the post of Assistant under the ICAR-IARI recruitment (Notification dated 07/05/2022). Many deserving candidates, including myself, who cleared the exam fairly and transparently, are facing prolonged uncertainty despite confirmed vacancies due to non-joining/resignation of selected candidates.

As per Para 10 of the notice dated 25/06/2024, such vacant posts were to be filled strictly from the waiting list. However, despite the lapse of time, no waiting list has been released. This is causing distress and unemployment among aspirants who have been patiently awaiting the next step in the process.

I earlier raised this issue through the PGPortal (Reg. No. PMOPG/E/2025/0035217) and appealed (No. DOARE/E/A/25/0000024), but both were closed without proper resolution. The reply mentioned a letter dated 24.04.2025, yet no such letter was provided, even after raising this during the appeal. Such handling of grievances undermines trust in the redressal mechanism.

It has also come to light that some already-selected candidates are making unauthorized requests for preferred postings, which goes against recruitment rules. The guidelines clearly state that once allocation is accepted, it is final. Any changes are only applicable to ICAR HQ vacancies due to resignation, which are to be filled from the waiting list—not through preferential claims.

Key Concerns:

Why is the waiting list not released despite available vacancies and official directions?



Why were grievances about ICAR HQ's role redirected to IARI, which lacks authority to release the waiting list?

Why was a waiting list released in the Technician (T-1) recruitment, but not for Assistant, despite both being central ICAR recruitments?

Why was my previous grievance closed without attaching the mentioned resolution letter or properly addressing my concern?

This issue highlights not just a recruitment delay but a larger concern of transparency, fairness, and accountability in public institutions. Aspirants who placed their trust in the process now face undue mental, emotional, and economic hardship.

I respectfully request your esteemed office to:

Direct the concerned authorities (ICAR HQ/DARE) to release the waiting list without further delay, as per guidelines.

Ensure grievances are addressed with transparency and not marked resolved without genuine resolution.

Prevent unauthorized influence in the post-allocation process that may harm fairness and merit.

<p>I am writing to escalate my grievance regarding the mismanagement in ICAR-IARI Assistant Recruitment waiting list and the lack of transparency and accountability in the process. My previous complaint through PG Portal was unjustly closed without addressing key concerns, further adding to the distress of deserving candidates.</p> <p>The ICAR-IARI recruitment notification clearly states that vacancies due to non-joining/resignation must be filled from the waiting list. However, despite multiple RTI replies confirming vacancies, ICAR-IARI has not acted. Their response vaguely states that approval from ICAR HQ is awaited, but there is no timeline or valid justification for this delay.</p> <p>Additionally, when I file a complaint against ICAR Headquarters through PG Portal, it is wrongly forwarded to IARI, which is not the final decision-making authority. This results in a lack of accountability, as ICAR HQ is the one responsible for granting approval for the waiting list, yet grievances meant for them are being redirected to IARI, leading to repeated misleading responses.</p> <p><b>Key Issues That Need Immediate Resolution:</b> Will ICAR-IARI release the waiting list as per the recruitment notification? If yes, when? If not, why is the official policy being ignored? Why has ICAR HQ not granted approval despite confirmed vacancies due to non-joining? What is causing this indefinite delay? Why was the waiting list followed in the Technicians (T-1) recruitment but ignored in the Assistant recruitment? Why was my PG Portal grievance closed without a proper response? Why is my complaint to ICAR HQ being repeatedly forwarded to IARI instead of being handled at the headquarters level? I request your urgent intervention to ensure fairness and transparency in this recruitment process. Candidates who have cleared the rigorous selection process should not suffer due to administrative mismanagement and unnecessary delays.</p>


