# SUBJECT: URGENT APPEAL FOR JUSTICE AGAINST UNLAWFUL EVICTION, EXCESSIVE FINANCIAL DEDUCTIONS, ONGOING HARASSMENT, AND DENIAL OF ENTITLED ACCOMMODATION

Respected Sir/Madam,

I am Dr. Yasin Jeshima K, a 45-year-old single woman and Senior Scientist in ICAR-National Bureau of Plant Genetic Resources (NBPGR), with over 15 years of dedicated service at ICAR-NBPGR, holding a Group A, position and currently residing at Quarter No. II-A/02, Type-II, Janak Vihar, PUSA Campus, New Delhi-110012.

I am writing to seek your urgent intervention regarding a series of grave injustices inflicted upon me by the authorities at ICAR-Indian Agricultural Research Institute (IARI). These include the unlawful seizure of my allotted accommodation, excessive financial deductions from my salary, persistent harassment and threats to forcibly vacate, and the denial of alternative entitled Type-V quarters despite eligibility.

That I was allotted Type-II quarter No. II-A/02, Janak Vihar, PUSA Campus, in July 2022 by the Senior Administrative Officer, Housing Section,

ICAR-IARI. Despite my eligibility for Type-V accommodation as a Senior Scientist, this lower-grade quarter was provided.

That a subsequent memorandum dated September 20, 2024 (F.No. 8-1/2019-Housing/864) and a letter dated October 3, 2024 (F.No. 8-1/2019-Housing/893) from the Assistant Administrative Officer further ordered my eviction within 15 days, threatening additional charges from October 5, 2024, without providing any reason, notice, or opportunity to be heard. As a single woman living alone, this eviction has rendered me homeless, severely compromising my safety and well-being.

That on March 5, 2025, an office order (No. 32-278/2000/Estate/Res Qtr/Pl-II/2649/3) was issued, demanding I vacate the quarter by February 28, 2025, citing unauthorized retention and imposing demurrage charges of Rs. 82,860/- (including Rs. 82,720/- for demurrage and Rs. 140/- for water charges) to be remitted to the Director, IARI's bank account.

That I have been allotted a Type II quarter, which carries an approximate monthly rent of ₹5,000. Despite this, my House Rent Allowance (HRA) has been unlawfully attached, and an exorbitant amount of ₹82,860/- (including ₹82,720/- for demurrage and ₹140/- for water charges) is being deducted monthly from my salary. This deduction far exceeds the expected quarterly charge for the Type II quarter, constituting financial exploitation and causing significant hardship. The deduction, particularly the demurrage charges, appears to be a punitive measure imposed without any justification, further aggravating my financial distress.

For over a year, I have been subjected to relentless harassment by Mr. Sainy's family, residing opposite my quarter. This includes abusive behavior, constant surveillance, tampering with my door, spreading rumors, and threatening remarks such as "bring matchbox, let me burn her house now" by Mrs. Sainy. The theft of my diamond bracelet coincided with Mr. Sainy's sudden acquisition of high-cost items, raising suspicions. When no action was taken against that family, to my wonder he was awarded a better quarter now; from where they can do 360° surveillance 24X 7 and will have access to my terrace where they will have their water tank.

Additionally, students from Kaveri Hostel have engaged in organized surveillance, following me daily from 8:30 AM to 9:30 PM across locations like DMS, Shishir, and Mother Dairy. Identified individuals (e.g., Iswarya Lakshumi, Bhavya, Swathi) have been intimidating me with stares, comments, and suspicious phone calls reporting my movements.

I have faced prior incidents, including an attack and jewellery theft near Saraswati Road, food theft by individuals on bicycles, unauthorized terrace access, and sharing of my photos outside the campus, leading to 107 blocked threatening contacts. These actions have created an unsafe environment, pressuring me to leave the institute.

That as a Group A, officer with an unblemished record, I am eligible for Type-V quarters. However, I was allotted a Type-II quarter, and now, despite my safety concerns and representations (dated September 24, 2024, and October 4, 2024), the authorities have proceeded with eviction without offering an alternative. My repeated requests for enhanced security and appropriate accommodation have been ignored, violating my rights and safety as a lone woman scientist.

Despite assurances from the Director, IARI, on September 23, 2024, to address my concerns seriously, no action has been taken, and the eviction process continues.

I humbly request your esteemed office to conduct a thorough inquiry into the unlawful eviction, excessive financial deductions, and harassment by Mr. Sainy's family and Kaveri Hostel inmates. Review CCTV footage and take strict disciplinary action against the perpetrators. Withdraw the eviction notice (memorandum dated September 20, 2024, and letter dated October 3, 2024) and restore my entitled Type-V accommodation within the campus. Reinstate the security post near DMS milk station and enhance campus security to protect me as a single woman. Cease the Rs. 82,000 monthly deductions and release my attached HRA, ensuring fair financial treatment. Direct ICAR-IARI and NBPGR authorities to adhere to due process and provide a fair resolution, protecting my rights as a dedicated public servant.

I trust in your authority to uphold justice and safeguard my dignity and safety. I am prepared to provide further evidence, including documents and witness statements, and am available to meet as required.
