It is submitted that my father Shri Pankaj Kumar Jha, serving as Assistant in RC, IARI, Pusa expired on 24.02.2021, while being in service. As per provisions, my mother has requested through application addressed to RC, IARI, Pusa for appointment of her elder son i.e. Shri Paritosh Pallav on compassionate basis vide Diary No. 1574 dated 09.11.2022. Subsequently, relevant documents were forwarded by RC, IARI Pusa vide L/No. 2022-23/R.C.P./83 dated 08.02.2023 to AAO(Pers-II), IARI, New Delhi-12, which was received in IARI, New Delhi on 15.02.2023 for sympathetic disposal. However, since then almost 03 years have elapsed for want of any favourable/sympathetic action.

Although, IARI, New Delhi (Pers-II) vide letter no. 13-1/2020-P-II dated 16.05.2025 has asked to forward afresh document in light of OM No. Admn.10-1/2025-R&P dated 01.05.2025 as per enclosures contained as Annexure 1,2,3&4 and subsequently, in compliance, all the asked documents have been immediately sent to Pers-II, IARI, New Delhi for further necessary action. However, despite an elapse of another 06 months, nothing positive regarding my appointment on compassionate basis has been intimated so far, which is leaving me in a state of baffleness.

Being desperate, I approached twice for redressal of my grievance/problem and for speedy disposal of the matter through CPGRAMS portal vide registration No. DOARE/E/2025/0000338 dated 02.06.2025 and registration no. DOARE/E/2025/0000622 dated 17.09.2025. However, on both the occasions it was communicated to me that matter of data compilation is under progress and upon compilation of data, all the files shall be kept before Compassionate Appointment Committee(CAC) of ICAR-IARI, New Delhi for recommendation of applicants for appointment on compassionate ground. Being an applicant, it is quite painful that data compilation of mere 220 applicants is taking such huge time despite keeping in view that all the applicants are already aggrieved due to loss of their beloved ones and due to subsequent, financial hardships being faced by them is quite understandable.

Although it is quite obvious that administrative processes do take time to reach its effective conclusion but delay of almost 04 years (since death of my father) is something which is completely unbearable and beyond toleratable. Due to sudden demise of my father, my family is already suffering a lot in financial as well as all societal terms. It was hoped that in case of my appointment, I shall shoulder financial responsibility of my family but unwarranted delay in appointment is leaving us in a state of desperation and hopelessness as to whom be approach for redressal of our grievance as neither there is any firm intimation regarding schedule dates by which all the processes shall be finalized nor any other intimation is being communicated in this regard.

In view of above, it is requested to kindly do the needful for speedy disposal of recruitment process pertaining to CAC and other formality so as to bring justice to the aggrieved applicants like me. This shall be construed as true expression of gratitude to all deceased in real terms, who were once a part and were instrumental in making this esteemed organization, great.

We shall be highly indebted for prompt disposal of the matter.

Reference is invited to the complaint received on CPGRAMS portal bearing registration No.DOARE/E/2026/0000012 dated 03-01-2026. In the said complaint, complainant has highlighted delay in processing the cases, about financial hardship and has requested speedy disposal of recruitment process pertaining to compassionate appointment.

In this regard it is submitted that new guidelines on compassionate appointment were issued by ICAR on 1st May, 2025. Thereafter, thrice the letter was sent to all the applicants calling for data as per new guidelines and accordingly detailed data of each case was prepared after thorough scrutiny of information/ documents submitted by all the applicants. In this connection, you have submitted the complete data i.e. graduation degree, to this office by November 2025 itself.

Furthermore, it is informed that matter of appointment on compassionate grounds is under consideration by the compassionate appointment committee of the Institute and recruitment process pertaining to appointment on compassionate grounds will be completed in due course of time.
