Respected Sir/Madam,

I am writing this to seek clarification and submit a suggestion regarding the release of the waiting list for the vacant posts of Assistants through Combined Assistant Grade Examination-2022 under the ICAR recruitment process. As per recent updates, ICAR is in the process of releasing the waiting list to fill the posts left vacant due to non-joining of candidates from the main list.

My queries are as follows:

What is the process being adopted for releasing the waiting list?

Is the list being released in one go or in multiple phases depending on vacancies arising from non-joining? How does ICAR plan to tackle the issue of candidates from the waiting list not joining?

As observed in many recruitments, a significant number of candidates from the waiting list also do not join, leading to unfilled vacancies and potential delays. If directly waiting list is released done the merit order than most of the post will remain vacant resulting in waste of time and resource.

In this regard, I would like to offer a constructive suggestion:

To maximize the filling of vacancies and avoid the need for multiple waiting lists or reallocation rounds, ICAR may consider conducting a "Willingness/Unwillingness or Counselling Process or any other process which ICAR may think is appropriate." for all DV-qualified candidates.

This can be done through a simple online portal/form where candidates can submit their willingness to join if selected for any particular institute.

Only those who show interest may be considered for allocation, thus reducing the number of unfilled posts due to non-joining.

This process can also help in saving administrative time and effort involved in publishing multiple waiting lists or reallocating posts.

I hope the competent authority will take this suggestion into consideration for a smoother and more efficient recruitment process that ensures maximum utilization of available vacancies.
