

Subject: Delay in compliance with ICAR OM dated 26.08.2025 regarding re-allocation of DR-Assistants (CAGE-2022)

Respected Sir/Madam,

This is to bring to notice that ICAR Headquarters issued Office Memorandum F.No. Admin.16-5/2024-R&P dated 26th August 2025 regarding re-allocation of DR-Assistants appointed through the Combined Assistant Grade Examination (CAGE)-2022.

The OM prescribed clear timelines, namely:

Issuance of offer of appointment by 30th August 2025, and

Joining of re-allocated DR-Assistants by 10th September 2025 after completion of resignation/relieving formalities.

It has come to attention that several Institutes/KVKs/Units have not adhered to these deadlines. The delay in issuing appointment/relieving orders has created uncertainty for the re-allocated Assistants and has also held up the process of filling vacancies from the reserve panel/waiting list of CAGE-2022.

The matter requires urgent attention so that the directions of ICAR Headquarters are implemented without further delay. It is therefore requested that necessary instructions may kindly be issued to ensure compliance with the OM and to avoid recurrence of such delays in future.
