

Text of RTI First Appeal :	1. The following points should be considered before refusing access to information requested: (a) The case of Angesh Kumar Vs UPSC, citing which my access to information has been refused, is altogether a specific case of UPSC. (b) UPSC is an autonomous organisation and the Exams conducted by it are guided by its rules and regulations, ICAR doesnt comes under UPSC. (c) Exams conducted by UPSC i.e. CSE is a exam which consists of multiple paper and pattern but this exam conducted by ICAR is a single paper exam which is same for all the participating candidates. (d) Also almost all the organisation, which are responsible for conducting Exams, in India voluntarily or on RTI request disclose copy of Descriptive Exam. (e) Disclosing copies of exams promotes transparency in the process of recruitment.
